ON APRIL 18, 2001, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED AN INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRY SUMMARIES WHICH ARE SUBJECT TO THE COUNTERVAILING DUTY ORDER ON GRAIN-ORIENTED ELECTRICAL STEEL FROM ITALY (C-475-812), MANUFACTURED OR EXPORTED BY ACCIAI SPECIALI TERNI S.p.A. FOR THE REVIEW PERIOD JANUARY 1, 1998 THROUGH DECEMBER 31, 1998.

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRY SUMMARIES OF SUBJECT MERCHANDISE WHICH WAS PRODUCED OR EXPORTED

BY ACCIAI SPECIALI TERNI S.p.A. AND WHICH WAS EXPORTED ON OR AFTER JANUARY 1, 1998 AND ON OR BEFORE DECEMBER 31, 1998. IN ADDITION, FOR ALL ENTRIES ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER JANUARY 1, 1999 THAT REMAIN UNLIQUIDATED AS OF 5'O CLOCK P.M. ON MAY 7, 2001, THE FIRST BUSINESS DAY AFTER THE DAY ON WHICH COPIES OF THIS ORDER WERE PERSONALLY SERVED ON THE APO UNIT/IMPORT ADMINISTRATION DOCKET CENTER, DO NOT LIQUIDATE.
