1. THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (66 FR 27629) ON 05/18/2001 THE FINAL RESULTS OF ITS NEW SHIPPER REVIEW OF A CERTAIN MANUFACTURER/EXPORTER SUBJECT TO

THE ANTIDUMPING ORDER ON STAINLESS STEEL BAR FROM INDIA FOR THE PERIOD 02/01/2000 THROUGH 9/30/2000.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES HAVE BEEN REVISED FOR A CERTAIN MANUFACTURER/EXPORTER. THEREFORE, FOR

SHIPMENTS OF STAINLESS STEEL BAR FROM INDIA ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 05/18/2001, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE FOLLOWING MANUFACTURER/EXPORTER:

5. THESE CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS FOR THE NEXT ADMINISTRATIVE REVIEW. DO NOT LIQUIDATE ANY ENTRIES COVERED BY THIS REVIEW UNTIL YOU HAVE RECEIVED LIQUIDATION INSTRUCTIONS.
