3. IF NO INFORMATION IS RECEIVED WITHIN 45 DAYS OF RECEIPT OF THIS MESSAGE, THE DEPARTMENT WILL ASSUME THAT THERE ARE NO UNLIQUIDATED ENTRIES OF THE SUBJECT MERCHANDISE.
