RE: Cash deposit instructions for the new shipper review of certain frozen fish fillets from Vietnam exported and produced by Ngoc Ha Co. Ltd. Food Processing and Trading (A-552-801-000)

1. On 07/03/2013, Commerce published in the Federal Register (78 FR 40100) the rescission of the new shipper review of the antidumping duty order on certain frozen fish fillets from the Socialist Republic of Vietnam for the period 08/01/2012 through 01/31/2013 (A-552-801).

2. Effective 07/03/2013, importers may no longer post a bond or other security in lieu of a cash deposit on imports of subject merchandise from the exporter/producer combinations listed below. For shipments of certain frozen fish fillets from the Socialist Republic of Vietnam entered, or withdrawn from warehouse, for consumption on or after 07/03/2013, the following cash deposit requirements apply to the exporter/producer combination listed below:

Exporter: Ngoc Ha Co. Ltd. Food Processing and Trading

Producer: Ngoc Ha Co. Ltd. Food Processing and Trading

Case number: A-552-801-000

Cash deposit rate: 2.11 dollars per kilogram

3. The cash deposit rate shown above applies only to the exporter/producer combination identified in paragraph 2. For entries of subject merchandise from the exporter and producer identified above in any other combinations, cash deposits only should be collected at the chain rate that applies to that other combination, or if no rate exists for that chain, at the country-wide Vietnam rate in effect on the date of entry. The country-wide Vietnam rate is 2.11 dollars per kilogram.

4. These cash deposit requirements will remain in effect until further notice. Do not liquidate any entries covered by this review until liquidation instructions are issued.
