BEARINGS FROM THE UNITED KINGDOM FOR THE PERIOD 05/01/1999
THROUGH 04/30/2000.

2. DUE TO THE REVOCATION OF CERTAIN ANTIDUMPING DUTY ORDERS PUBLISHED BY THE DEPARTMENT OF COMMERCE IN THE FEDERAL REGISTER (65 FR 42667) ON 07/11/2000, NO DEPOSIT RATE FOR BALL BEARINGS FROM SWEDEN

(A-401-201) WILL GO INTO EFFECT AND NO CASH DEPOSIT IS REQUIRED FOR ENTRIES OF THIS MERCHANDISE. THE REMAINING DEPOSIT INSTRUCTIONS IN THIS MESSAGE APPLY TO NON-REVOKED ORDERS.

3. AS A RESULT OF COMMERCE'S REVIEWS, THE CASH DEPOSIT RATES HAVE BEEN REVISED FOR CERTAIN MANUFACTURERS AND EXPORTERS OF BALL BEARINGS AND PARTS THEREOF FROM THE UNITED KINGDOM. THEREFORE, FOR SHIPMENTS OF BALL BEARINGS AND PARTS THEREOF FROM THE UNITED KINGDOM ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 07/12/2001, THE REQUIRED CASH DEPOSITS HAVE BEEN REVISED AS FOLLOWS:
