1. The Department of Commerce has completed its administrative review of the countervailing duty order on apparel from Argentina and published the final results in the Federal Register on August 23, 1991 (56 FR 41823).
2. Imports covered by the review are shipments of certain apparel from Argentina. Such merchandise is classifiable under the Harmonized Tariff Schedule items listed in CIE N-208\84, Suppl. 41, February 22, 1989.

3. Accordingly, for shipments of Argentine apparel entered, or withdrawn from warehouse, for consumption on or after August 23, 1991, you shall collect a cash deposit equal to the amount listed below for the manufacturers\exporters noted:
