1. THIS MESSAGE IS A CORRECTION TO MESSAGE # 1275201 DATED 10/02/2001 ON AUTOMATIC LIQUIDATION FOR GRAIN-ORIENTED ELECTRICAL STEEL FROM ITALY. MESSAGE # 1275201 WAS INCORRECT AND IS NOT VALID. THIS MESSAGE CORRECTS MESSAGE # 1275201.

2 THE DEPARTMENT OF COMMERCE DID NOT RECEIVE A REQUEST FOR AN ADMINISTRATIVE REVIEW OF THE

COUNTERVAILING DUTY ORDER ON GRAIN-ORIENTED ELECTRICAL STEEL FROM ITALY (C-475-812) FOR THE PERIOD 01/01/2000 THROUGH 12/31/2000.

3. THE PRODUCT COVERED BY THIS ORDER IS GRAIN-ORIENTED ELECTRICAL STEEL, WHICH IS A FLAT-ROLLED ALLOY STEEL PRODUCT CONTAINING BY WEIGHT AT LEAST 0.6 PERCENT OF SILICON, NOT MORE THAN 0.08 PERCENT OF CARBON, NOT MORE THAN 1.0 PERCENT OF ALUMINUM, AND NO OTHER ELEMENT IN AN AMOUNT THAT WOULD GIVE THE STEEL THE CHARACTERISTICS OF ANOTHER ALLOY STEEL, OF A THICKNESS OF NO MORE THAN 0.56 MILLIMETERS, IN COILS OF ANY WIDTH, OR IN STRAIGHT LENGTHS WHICH ARE OF A WIDTH MEASURING AT LEAST 10 TIMES THE THICKNESS.

4. THEREFORE, IN ACCORDANCE WITH SECTION 351.212(C) OF THE COMMERCE REGULATIONS, YOU ARE TO ASSESS COUNTERVAILING DUTIES AT RATES EQUAL TO THE CASH DEPOSIT OF ESTIMATED COUNTERVAILING DUTIES REQUIRED AT THE TIME OF ENTRY ON THE SPECIFIED SUBJECT MERCHANDISE EXPORTED ON OR AFTER 01/01/2000 AND ON OR BEFORE 12/31/2000 EXCEPT FOR MERCHANDISE PRODUCED BY THE COMPANY ACCIAI SPECIALI TERNI S.P.A (AST) OR IMPORTED BY ACCIAI SPECIALI TERNI (AST USA) (C-475-812-001). AS EXPLAINED IN MESSAGE # 1138203, ENTRIES MANUFACTURED OR EXPORTED BY AST OR IMPORTED BY AST USA (C-475-812-001) ARE ENJOINED FROM LIQUIDATION DUE TO AN APRIL 18, 2001 INJUNCTION ISSUED BY THE U.S. COURT OF INTERNATIONAL TRADE.

5. THE RATES OF ESTIMATED COUNTERVAILING DUTIES WHICH WERE REQUIRED TO BE DEPOSITED ARE:

6. THE SUSPENSION OF LIQUIDATION ORDERED FOR THE MERCHANDISE LISTED ABOVE EXPORTED ON OR AFTER 01/01/2000 AND ON OR BEFORE 12/31/2000 BY ALL OTHER COMPANIES EXCEPT AST AND AST USA IS LIFTED. THE SUSPENSION OF LIQUIDATION FOR ALL SHIPMENTS OF THE MERCHANDISE LISTED ABOVE EXPORTED AFTER 12/31/2000 WILL CONTINUE.

7. THE ASSESSMENT OF COUNTERVAILING DUTIES BY THE CUSTOMS SERVICE ON SHIPMENTS OR ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930. SECTION 778 REQUIRES THAT CUSTOMS PAY INTEREST ON OVERPAYMENTS, OR ASSESS INTEREST ON UNDERPAYMENTS, OF THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED COUNTERVAILING DUTIES. THE INTEREST PROVISIONS ARE NOT APPLICABLE TO CASH OR BONDS POSTED AS ESTIMATED COUNTERVAILING DUTIES BEFORE THE DATE OF PUBLICATION OF THE COUNTERVAILING DUTY ORDER. INTEREST SHALL BE CALCULATED FROM THE ENTRY DATE OR DATE OF DEPOSIT WHICHEVER IS LATER, OF ESTIMATED COUNTERVAILING DUTIES THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.
