RE: Liquidation instructions for wooden bedroom furniture from the People's Republic of China ("PRC") exported by the PRC-wide entity for the period 01/01/2011 through 12/31/2011 (A-570-890)

1. For all shipments of wooden bedroom furniture from the PRC exported by the PRC-wide entity (A-570-890-000) entered, or withdrawn from warehouse, for consumption during the period 01/01/2011 through 12/31/2011, assess an antidumping liability equal to 216.01 percent of the entered value of subject merchandise.

2. In Commerce's final results, 78 FR 35249, 06/12/2013, Commerce determined that the following exporters are no longer eligible for a separate rate and are considered part of the PRC-wide entity:

Therefore, CBP shall liquidate entries of wooden bedroom furniture from the PRC which were exported by the firms listed above in this paragraph and entered, or withdrawn from warehouse, for consumption during the period 01/01/2011 through 12/31/2011 in accordance with the instructions in paragraph 1 above for the PRC-wide entity. 3. In addition, in Commerce's final results, 78 FR 35249, 06/12/2013, Commerce determined that the following exporter is no longer eligible for a separate rate and is considered part of the PRC-wide entity:

Shanghai Maoji Import and Export Corporation Limited

As noted in paragraph 6 below, an injunction is in effect for entries which were both exported by Shanghai Maoji Import and Export Corporation Limited, and imported by Mark David, a Division of Baker, Knapp & Tubbs, Inc. Therefore, CBP shall liquidate entries of wooden bedroom furniture from the PRC which were exported by Shanghai Maoji Import and Export Corporation Limited, imported by any company other than Mark David, a Division of Baker, Knapp & Tubbs, Inc. and entered, or withdrawn from warehouse, for consumption during the period 01/01/2011 through 12/31/2011 in accordance with the instructions in paragraph 1 above for the PRC-wide entity. Entries of such merchandise may have entered under case number A-570-890 051.

4. In addition, the following exporters were part of the PRC-wide entity during the period 01/01/2011 through 12/31/2011. Therefore, CBP shall liquidate entries of wooden bedroom furniture from the PRC exported by the following firms and entered, or withdrawn from warehouse, for consumption during the period 01/01/2011 through 12/31/2011 in accordance with the instructions in paragraph 1 above for the PRC-wide entity. The notice of lifting of suspension of liquidation for entries of subject merchandise covered by paragraphs 1, 2, 3, and 4 occurred with the publication of the final results of administrative review (78 FR 35249, 06/12/2013). Unless instructed otherwise, for all other shipments of wooden bedroom furniture from the PRC, you shall continue to collect cash deposits of estimated

antidumping duties for the merchandise at the current cash deposit rates or per-unit amounts.

6. The injunction with court number 13-00233 discussed in message number 3183301 dated 07/02/2013 is applicable to the entries which were both exported by Shanghai Maoji Import and Export Corporation Limited, and imported by Mark David, a Division of Baker, Knapp & Tubbs, Inc. which were entered, or withdrawn from warehouse, for consumption between 01/01/2011 through 12/31/2011. Accordingly, until further notice continue to suspend liquidation of these entries until liquidation instructions are issued.

7. The assessment of antidumping duties by CBP on shipments or entries of this merchandise is subject to the provisions of section 778 of the Tariff Act of 1930, as amended. Section 778 requires that CBP pay interest on overpayments or assess interest on underpayments of the required amounts deposited as estimated antidumping duties. The interest provisions are not applicable to cash or bonds posted as estimated antidumping duties before the date of publication of the antidumping duty order. Interest shall be calculated from the date payment of estimated antidumping duties is required through the date of liquidation. The rate at which such interest is payable is the rate in effect under section 6621 of the Internal Revenue Code of 1954 for such period.

8. Upon assessment of antidumping duties, CBP shall require that the importer provide a reimbursement statement, as described in section 351.402(f)(2) of Commerce's regulations. The importer should provide the reimbursement statement prior to liquidation of the entry. If the importer certifies that it has an agreement with the producer, seller, or exporter, to be reimbursed antidumping duties, CBP shall double the antidumping duties in accordance with the above-referenced regulation. Additionally, if the importer does not provide the reimbursement statement prior to liquidation, reimbursement shall be presumed and CBP shall double the antidumping duties due. If an importer timely files a protest challenging the presumption of reimbursement and doubling of duties, consistent with CBP's protest process, CBP may accept the reimbursement statement filed with the protest to rebut the presumption of reimbursement.
