THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (66 FR 42507) ON AUGUST 13, 2001, THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF CERTAIN MANUFACTURERS/EXPORTERS SUBJECT TO THE ANTIDUMPING DUTY ORDER ON CERTAIN PRESERVED MUSHROOMS FROM INDIA FOR THE PERIOD OF AUGUST 5, 1998, THROUGH JANUARY 31, 2000.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES

HAVE BEEN REVISED FOR CERTAIN MANUFACTURES/EXPORTERS.  
THEREFORE, FOR SHIPMENTS OF CERTAIN PRESERVED MUSHROOMS FROM  
INDIA ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION  
ON OR AFTER AUGUST 13, 2001, THE REQUIRED CASH DEPOSIT HAS  
BEEN REVISED FOR THE FOLLOWING MANUFACTURERS/EXPORTERS:

4. FOR ALL MANUFACTURERS/EXPORTERS OF CERTAIN PRESERVED MUSHROOMS FROM INDIA WITHOUT THEIR OWN RATE, THE CASH DEPOSIT RATE IS 11.30 PERCENT.

5. THESE CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS FOR THE NEXT ADMINISTRATIVE REVIEW. DO NOT LIQUIDATE ANY ENTRIES COVERED BY THIS REVIEW UNTIL YOU HAVE RECEIVED LIQUIDATION INSTRUCTIONS.
