RE: Prelim. inj. on fresh garlic from the PRC for Weifang Hongqiao International Logistics Co., Ltd. and Qingdao Xintianfeng Foods Co., Ltd., 11/01/2010 - 10/31/2011 (A-570-831), court #13-00228

1. On 07/03/2013, the U.S. Court of International Trade issued a preliminary injunction enjoining liquidation of certain entries which are subject to the antidumping duty order on fresh garlic from the People's Republic of China (A-570-831) for the period 11/01/2010 through 10/31/2011.

2. This injunction was issued in connection with court case number 13-00228 and enjoins liquidation of the entries described in paragraph 3 below.

3. Accordingly, until further notice, do not liquidate entries of subject merchandise which were: subject to the antidumping duty order on fresh garlic from the People's Republic of China (A-570-831), and were the subject of the U.S. Department of Commerce's final results of antidumping administrative review (78 FR 36168, 06/17/2013); exported by Weifang Hongqiao International Logistics Co., Ltd. or by Qingdao Xintianfeng Foods Co., Ltd., and which were entered, or withdrawn from warehouse, for consumption during period 11/01/2010 through 10/31/2011. Any entries that are set for liquidation must be unset immediately. Continue to suspend liquidation of these entries until liquidation instructions are issued:

4. Liquidation instructions for entries affected by the injunction have not yet been issued.

5. Effective immediately, CBP is instructed to prevent liquidation of any entries subject to the above.

6. Commerce's APO Docket Center was served with the above-referenced injunction on 07/08/2013. Pursuant to the terms of the injunction, no liquidation of the entries covered by the injunction may be made for entries which remain unliquidated as of the first business day after which copies of this order are personally served on Commerce's APO Docket Center.
