1. THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (66 FR 45006) ON AUGUST 27, 2001, THE FINAL RESULTS OF ITS NEW SHIPPER REVIEW OF CERTAIN PRESERVED MUSHROOMS FROM THE PEOPLE'S REPUBLIC OF CHINA FOR THE PERIOD 02/01/2000 THROUGH 07/31/2000.

2. AS A RESULT OF COMMERCE'S REVIEW, A CASH DEPOSIT RATE HAS BEEN ESTABLISHED FOR GREEN FRESH FOODS (ZHANGZHOU) CO., LTD.

THEREFORE, FOR SHIPMENTS OF CERTAIN PRESERVED MUSHROOMS FROM

THE PEOPLE'S REPUBLIC OF CHINA ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER AUGUST 27, 2001, ASSIGN THIS COMPANY A CASH DEPOSIT AS FOLLOWS:

5. THESE CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS OF THE NEXT

ADMINISTRATIVE REVIEW FOR GREEN FRESH FOODS (ZHANGZHOU) CO., LTD. DO NOT LIQUIDATE ANY ENTRIES COVERED BY THIS REVIEW UNTIL YOU HAVE RECEIVED LIQUIDATION INSTRUCTIONS.
