1. The Department of Commerce will publish in the Federal Register on September 12, 1991, notice of its preliminary determination that shop towels from Bangladesh are being sold in the United States at less than fair value.

2. The product covered by this investigation is shop towels.

Shop towels are currently provided for under HTS subheadings 6307.10.2005, and 6307.10.2015. For purposes of this investigation, shop towels are absorbent industrial wiping cloths

made from a loosely woven fabric. The fabric may be either 100 percent cotton or a blend of materials.

3. For further reporting purposes this case has been assigned the following investigation number A-538-802.

4. For all exports of shop towels from Bangladesh, the Customs Service shall suspend liquidation of such shop towels that are entered or withdrawn from warehouse on or after September 12, 1991, and shall require a cash deposit of the posting of a bond equal to the estimated preliminary margin percentages listed below.
