1. THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (66 F.R.. 40987) OF AUGUST 6, 2001, THE PRELIMINARY RESULT AND PARTIAL RESCISSION OF ITS ADMINISTRATIVE REVIEW OF THE COUNTERVAILING DUTY ORDER (C-475-819) ON CERTAIN PASTA FROM ITALY FOR THE PERIOD (01/01/1999 - 12/31/1999).

2. THE ADMINISTRATIVE REVIEW HAS BEEN RESCINDED FOR SEVERAL COMPANIES. IMPORTS COVERED BY THE REVIEW ARE SHIPMENTS OF SCOPE DESCRIPTION OF THE PRODUCT AND CORRESPONDING HARMONIZED TARIFF

ORDER. INTEREST SHALL BE CALCULATED FROM THE DATE OF PAYMENT OF ESTIMATED ANTIDUMPING DUTIES THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.

5. THE SUSPENSION OF LIQUIDATION ORDERED FOR THIS MERCHANDISE EXPORTED ON OR BEFORE (12/31/1999) IS LIFTED. SUSPENSION OF LIQUIDATION FOR ALL ENTRIES OF THIS MERCHANDISE EXPORTED AFTER (12/31/1999) WILL CONTINUE.
