RE: Preliminary Injunction on Polyethylene Terephthalate Film, Sheet, and Strip from the People's Republic of China for the period 11/01/2010 through 10/31/2011 (A-570-924), court number 13-00229

1. On 07/02/2013, the U.S. Court of International Trade issued a preliminary injunction enjoining liquidation of certain entries which are subject to the antidumping duty order on polyethylene terephthalate film, sheet, and strip from the People's Republic of China (A-570-924) for the period 11/01/2010 through 10/31/2011.
2. This injunction was issued in connection with court case number 13-00229 and enjoins liquidation of the entries described in paragraph 3 below.
3. Accordingly, until further notice, do not liquidate entries of subject merchandise that were exported by DuPont Teijin Films China Limited and imported by DuPont Teijin Films U.S. Limited Partnership; that were the subject of the determination in Polyethylene Terephthalate Film, Sheet, and Strip from the People's Republic of China: Final Results of Antidumping Duty Administrative Review; 2010-2011 ("Final Results"), 78 Fed. Reg. 35,245 (Dep't Commerce June 12, 2013), and that were entered, or withdrawn from warehouse, for consumption during the period 11/01/2010 through 10/31/2011. Any entries that are set for liquidation must be unset immediately. Continue to suspend liquidation of these entries until liquidation instructions are issued.
4. Liquidation instructions for entries affected by the injunction have not yet been issued.
5. Effective immediately, CBP is instructed to prevent liquidation of any entries subject to the above.
6. Commerce's APO Docket Center was served with the above-referenced injunction on 07/02/2013. Pursuant to the terms of the injunction, no liquidation of the entries covered by the injunction may be made for entries which remain unliquidated as of 5:00 P.M. on the business day following the date on which copies of this order are personally served on Commerce's APO Docket Center.
