ON 10/17/2001, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES OF BALL BEARINGS AND PARTS THEREOF (BBs) AND CYLINDRICAL ROLLER BEARINGS AND PARTS THEREOF (CRBs) THAT WERE EXPORTED FROM JAPAN BY NSK LTD. THIS INJUNCTION ONLY COVERS BBs WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD

MAY 1, 1999, THROUGH APRIL 30, 2000, AND CRBs THAT WERE ENTERED,

OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD

MAY 1, 1999, THROUGH DECEMBER 31, 1999. THE CIT COURT NUMBER IS 01-00688.

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE SAID ENTRIES OF BBs AND CRBs WHICH WERE EXPORTED FROM JAPAN BY NSK LTD. THIS INJUNCTION ONLY COVERS SAID COMPANY'S BBs WHICH WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE

PERIOD MAY 1, 1999, THROUGH APRIL 30, 2000, AND FOR CRBs THAT WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING

THE PERIOD MAY 1, 1999, THROUGH DECEMBER 31, 1999. UNLESS OTHERWISE INSTRUCTED, CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED. ANY ENTRIES OF THE ABOVE-DESCRIBED MERCHANDISE WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.
