RE: TERMINATION OF THE ANTIDUMPING INVESTIGATION OF PURE MAGNESIUM FROM ISRAEL (A-508-809)

1. ON NOVEMBER 13, 2001, THE INTERNATIONAL TRADE COMMISSION (ITC) NOTIFIED THE DEPARTMENT OF COMMERCE OF ITS NEGATIVE FINAL DETERMINATION IN THE ANTIDUMPING INVESTIGATION OF PURE MAGNESIUM FROM ISRAEL. ACCORDINGLY, THE ANTIDUMPING DUTY INVESTIGATION OF PURE MAGNESIUM FROM ISRAEL HAS BEEN TERMINATED.

2. FIELD OFFICES SHOULD DISCONTINUE SUSPENSION OF LIQUIDATION OF ALL SHIPMENTS OF THIS MERCHANDISE ENTERED, OR WITHDRAWN FROM

WAREHOUSE, FOR CONSUMPTION ON OR AFTER APRIL 30, 2001. ALL ESTIMATED ANTIDUMPING DUTIES DEPOSITED ON ENTRIES OF THE SUBJECT MERCHANDISE SHALL BE REFUNDED AND THE BONDS OR OTHER SECURITY RELEASED AT THE TIME OF LIQUIDATION.

3. INTEREST PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930 DO NOT APPLY.
