1. THE DEPARTMENT OF COMMERCE HAS COMPLETED ITS ADMINISTRATIVE REVIEW OF THE CVD ORDER ON PIG IRON FROM BRAZIL (C-351-062) AND PUBLISHED THE FINAL RESULTS IN THE FEDERAL REGISTER ON MARCH 26, 1992 (57 FR 10460). THE REVIEW COVERED THE PERIOD JANUARY 1, 1990 THROUGH DECEMBER 31, 1990.

2. IMPORTS COVERED BY THIS REVIEW ARE SHIPMENTS OF PIG IRON OF BASIC, MALLEABLE, AND LOW PHOSPHOROUS GRADES. DURING THE REVIEW PERIOD, SUCH MERCHANDISE WAS CLASSIFIABLE UNDER ITEM NUMBERS 7201.10.00, 7201.30.00, AND 7206.10.00 OF THE

HARMONIZED TARIFF SCHEDULE (HTS).

3. ACCORDINGLY, FOR SHIPMENTS OF BRAZILIAN PIG IRON ENTERED, OR WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION ON OR AFTER MARCH 26, 1992, YOU ARE TO WAIVE THE CASH DEPOSIT REQUIREMENT.
4. THESE CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL THE FINAL RESULTS OF THE NEXT ADMINISTRATIVE REVIEW.
5. DO NOT LIQUIDATE ANY ENTRIES OF MERCHANDISE INCLUDED IN THIS ADMINISTRATIVE REVIEW UNTIL ASSESSMENT INSTRUCTIONS ARE ISSUED.
