THE DEPARTMENT OF COMMERCE HAS COMPLETED ITS ADMINISTRATIVE REVIEW OF THE ANTIDUMPING DUTY ORDER ON TAPERED ROLLER BEARINGS AND PARTS THEREOF, FINISHED AND UNFINISHED, FROM JAPAN, AND PUBLISHED THE FINAL RESULTS IN THE FEDERAL REGISTER ON FEBRUARY 11, 1992 (57 FR 4960) AND THE AMENDED FINAL RESULTS IN THE FEDERAL REGISTER ON MARCH 16, 1992 (57 FR 9104).

2. ACCORDINGLY, FOR SHIPMENTS OF JAPANESE TAPERED ROLLER

BEARINGS AND PARTS THEREOF, FINISHED AND UNFINISHED, ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER MARCH 16,

1992, YOU SHALL COLLECT A CASH DEPOSIT EQUAL TO THE AMOUNTS LISTED BELOW FOR EACH MANUFACTURER:

INSTRUCTIONS WILL NOT BE SENT UNTIL AT LEAST 30 DAYS AFTER PUBLICATION OF THE FINAL RESULTS, AND MAY BE DELAYED INDEFINITELY IF AN APPEAL OF THE FINAL DETERMINATION IS FILED WITH THE COURT OF INTERNATIONAL TRADE.
