THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (67 FR 2194) ON 01/16/2002 THE AMENDED FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF CERTAIN MANUFACTURERS/EXPORTERS SUBJECT TO THE ANTIDUMPING ORDER ON STAINLESS STEEL SHEET AND STRIP FROM KOREA FOR THE PERIOD 01/04/1999 THROUGH 06/30/2000.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES HAVE BEEN REVISED FOR CERTAIN MANUFACTURERS/EXPORTERS. THEREFORE, FOR

SHIPMENTS OF STAINLESS STEEL SHEET AND STRIP FROM KOREA ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 01/16/2002, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE FOLLOWING MANUFACTURERS/EXPORTERS:

POHANG IRON AND STEEL CO., LTD.	A-580-834-002	0.00 PERCENT
SAMWON PRECISION METALS CO., LTD	A-580-834-004	7.88 PERCENT
DAIYANG METAL CO., LTD.	A-580-834-005	2.74 PERCENT

3. IF ANY ENTRIES OF THIS MERCHANDISE ARE EXPORTED BY A FIRM OTHER THAN THE MANUFACTURER, THEN THE FOLLOWING INSTRUCTIONS APPLY: A. WHERE NEITHER THE EXPORTER NOR THE MANUFACTURER CURRENTLY HAS ITS OWN RATE OR THE MANUFACTURER IS UNKNOWN, USE THE 'ALL OTHER' RATE FOR ESTABLISHING THE CASH DEPOSIT RATE.

4. FOR ALL MANUFACTURERS/EXPORTERS OF STAINLESS STEEL SHEET AND STRIP FROM KOREA WITHOUT THEIR OWN RATE, THE CASH DEPOSIT RATE IS 2.49 PERCENT.

5. THESE CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS FOR THE NEXT ADMINISTRATIVE REVIEW. DO NOT LIQUIDATE ANY ENTRIES COVERED BY THIS REVIEW UNTIL YOU HAVE RECEIVED LIQUIDATION INSTRUCTIONS.
