2. ACCORDINGLY, FOR SHIPMENTS OF THE SUBJECT MERCHANDISE ENTERED OR WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION ON OR AFTER JANUARY 28, 1992, YOU SHALL COLLECT A CASH DEPOSIT

6. THESE CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS OF THE NEXT ADMINISTRATIVE REVIEW.

7. DO NOT LIQUIDATE ANY ENTRIES OF THE SUBJECT MERCHANDISE UNTIL YOU RECEIVE APPRAISEMENT INSTRUCTIONS.
