1. ON 04/08/2002, IN RESPONSE TO A REQUEST BY ATICO INTERNATIONAL, INC. (ATICO), THE DEPARTMENT OF COMMERCE ISSUED A FINAL SCOPE RULING THAT ATICO'S VALENTINE HEART CANDLE (ITEM NO. C78H-0251), EASTER EGG WITH ENGRAVED DUCK CANDLE (ITEM NO. C81H-0017), EASTER GLOWING EGG CANDLE (ITEM NO. H81H-0296), EASTER FLOATING CANDLE (ITEM NO. C81H-0016), CIRCULAR GROOVES LANTERN CANDLE (ITEM NO. C05F-2325), STRAIGHT GROOVES LANTERN CANDLE (ITEM NO. C0DF-2324), AND FLOATING CANDLE WITH VALENTINE HEART AND LIP DESIGN (ITEM NO. C78H-0384) ARE WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING PETROLEUM WAX CANDLES FROM THE

PEOPLE'S REPUBLIC OF CHINA (A-570-504).

2. BECAUSE THE IMPORTED PRODUCTS INCLUDE SHAPES SPECIFICALLY INCLUDED IN THE SCOPE OF THE ORDER, AND DO NOT FULFILL THE REQUIREMENTS FOR THE DEPARTMENT'S JULY 1987 NOVELTY CANDLE EXCEPTION, THE COMMERCE DEPARTMENT FOUND THESE PRODUCTS TO BE WITHIN THE SCOPE OF THE ORDER.

3. CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA, INCLUDING ATICO'S VALENTINE HEART CANDLE (ITEM NO. C78H-0251), EASTER EGG WITH ENGRAVED DUCK CANDLE (ITEM NO. C81H-0017), EASTER GLOWING EGG CANDLE (ITEM NO. H81H-0296), EASTER FLOATING CANDLE (ITEM NO. C81H-0016), CIRCULAR GROOVES LANTERN CANDLE (ITEM NO. C05F-2325), STRAIGHT GROOVES LANTERN CANDLE (ITEM NO. C0DF-2324), AND FLOATING CANDLE WITH VALENTINE HEART AND LIP DESIGN (ITEM NO. C78H-0384) LISTED ABOVE, SUBJECT TO THE ANTIDUMPING DUTY ORDER COVERING PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA.
